



POOL RULES AND REGULATIONS - 2020

- Due to the present restrictions in force due to the ongoing Covid-19 pandemic, social distances principles will be enforced. Only the stipulated number of patrons will be allowed inside the pool at any given time. With the present restrictions in force the pool can take up to 54 members at any one time.
- The Tigne Point Pool is open from Monday to Sunday, from 9:30AM to 7:30PM.
- The pool is open ONLY to members in possession of a valid membership card.
- The membership card must be shown at the pool reception desk prior to entering the pool area. If members fail to produce their Membership Card, entry will not be granted to the pool. Members are to wait for entry on the designated floor marks which observe the social distancing principle.
- All Membership Cards are personalized and non-transferrable. Membership Cards are to be used by the person named on the card only.
- Patrons will be allowed in on first come - first served principle. The management cannot restrict usage time of the pool but respect to members waiting sunbed availability is solicited.
- Patrons cannot reserve sunbeds either by placing towels on sunbeds or through the pool receptionist. Should this occur the pool receptionist is instructed to remove any items left unattended on the sunbeds.
- Once used, all sunbeds will be removed to be disinfected. These will be replaced with disinfected sunbeds. All deck, pool furniture and pool common areas are disinfected daily and as required.
- Toilets, showers and changing rooms are disinfected every 1 hour. No more than 6 persons at a time will be allowed inside the showers and toilets. This will be controlled on site.
- No children are to be left to run about the pool deck areas. Children can play freely in the turfed area ONLY if parents are sitting in this area or no patrons are using the area.
- No unattended young children will be allowed alone in the toilets and showers. Misbehaving children in these areas will be asked to leave the pool.
- Children under twelve years (12) are always to be accompanied and supervised.
- Toddlers under two years old are NOT allowed in the adult pool (even if accompanied) and those under three are to wear swim-diapers.
- MIDI plc reserves the right to withdraw membership cards of un-cooperative patrons.
- Children under twelve (12) years using the wading pool (children's pool) must be supervised by an adult.
- No diving or jumping is allowed in the pools.
- Toys, balls, inflatable toys, and rafts are NOT PERMITTED in the adult pool when this is being used by adults. Buoyancy aids are permitted.
- Noise levels are always to be kept to a minimum – especially between the hours of 2pm and 4pm.
- No parties are to be organised within the facility without the express written consent of MIDI plc.



- **Headphones must be worn when listening to musical or entertainment devices.**
- **Patrons who have suntan lotions or body creams on are to shower before using the pool.**
- **Appropriate swimwear / clothing is to be worn at all times. No topless / nude bathing is permitted.**
- **Any member caught abusing facilities and /or equipment will be asked to pay for damages and the membership card will be withdrawn.**
- **Persons who have an ear infection or a communicable condition or disease must not use the pools.**
- **Do not wear glasses in the pools unless necessary. Non-breakable lenses and frames are necessary for safety.**
- **No glassware is to be taken into the pool.**
- **No pets are to be brought into the pool complex.**
- **No food, drinks, deck-chairs, sun-beds or beach umbrellas are to be brought into the facility.**
- **MIDI plc or its operators / managers shall not be liable for any loss or theft that may occur in or on facilities.**
- **MIDI plc or its operators / managers do not accept responsibility for injury or damage.**
- **Members are to follow any reasonable directions which may be given to them for reasons of health and safety, access restrictions or works in the vicinity.**
- **Although lifesaving equipment is in place THE POOL IS NOT MANNED BY A LIFE-GUARD.**

PLEASE CO-OPERATE WITH THE POOL RECEPTIONIST IN ENFORCING THE RESTRICTIVE MEASURES IMPOSED BY THE AUTHORITIES. ANY DIFFICULTIES ARE TO BE RAISED WITH MIDI PLC'S MANAGEMENT.
